AGM & Annual Convention

The 72nd Annual General Meeting (AGM) was earlier scheduled for 16th October 2020 as a 'hybrid meeting'. It was expected that a limited number of members would gather onsite and the majority of members would join online via Zoom platform. Exactly one week before the date, the government took measures to partially lockdown the country due to the second wave of Covid-19 in the country banning all gatherings until further notice. Hence, the executive committee was compelled to postpone the event at the special Zoom meeting held on 10th October 2020.

The AGM was re-scheduled for 18th December 2020 adhering considering the safety of members as well.

The consumption of livestock products has dramatically increased over the last few years with the increase of per capita income of people and urbanization. Livestock industry of the country which contributes enormously to the GDP needs our expertise.

Our $73^{\rm rd}$ Executive committee is getting appointed in a crucial juncture where we have to carry the responsibility on our shoulders as veterinarians to eradicate rabies from this Island nation, by 2030.

We are getting appointed when the country is facing numerous disasters, losing their lives and properties due to Human Elephant Conflict.

We are further being elected when the country requires a dramatic change in its legal framework to address episodes of human violence against animal freedom.

Therefore we strongly believe on establishing as a one health forum under collaborative umbrella to conquer these burning issues in the country.

As we all know, the concept of one health is to work together to form a collaborative effort with medical professionals, scientists, environmentalists, government policy makers and any other stake holder to achieve the best health for people and animals in the country with conservation of our environment.

Considering these salient needs, under the present day perspectives, as the president, my theme for coming tenure will be "Empowering Veterinarians through Professional Collaboration and Knowledge Enhancement"

In par with this theme I would like to set 07 Goals for the SLVA for my committee:

- To perform as an active mediator in finding solutions with regard to Rabies Eradication Campaign, Human Elephant Conflict and to form a One health Forum.
- To form an e-platform for the pet owners and farmers for provision of medical and clinical advices from a distance under this COVID situation. This innovative platform will cater to the present day needs of the general public. This is already in practice by the medical counterparts as DOC 990. This new e-platform I suggest to be named as VET 990
- And we wish to join hands with Faculty to change the Attitudes of Veterinary Students Community in order to produce productive veterinarians who will have the passion to develop livestock production sectors in the country. I should say we hardly get students in the faculty who have selected veterinary profession as their first choice. We should accept that we have a passive start. We have to defiantly address this situation and actively involve in organizing Carrier Guidance

Programs and actually convince them as how diversified we are. Further, we should continuously engage with Professional Development Programs for the enhancement of knowledge of veterinarians on the fields of livestock, wild life & zoo and small animal sector.

- We should collaborate the SLVA with the other sister veterinary associations namely, State Veterinary Association, Wild life Veterinary Association, Sri Lanka College of Veterinary Surgeons, Veterinary Alumni of University of Peradeniya, World Poultry Science Association Sri Lankan Branch, Sri Lanka Association for Laboratory Animals, Society of Companion animal Practitioners of Sri Lanka.
- We should formulate a Strategic plan for the SLVA with setting of Goals and Core values which will serve as a policy guideline for the present and future executive committees in planning the events
- We should establish a Media Platform for the SLVA as a milestone in creating the Voice of Veterinarians in Sri Lanka for the provision of evidence based reliable information in a simple but scientific way to the general public. Convince the public with the opinion of SLVA on veterinary related national issues and dissemination of knowledge on matters of public health importance and information on scientific research findings will be the core aims of this venture.
- To promote the veterinary profession in the country with organizing of a mass educational and scientific exhibition in collaboration with Veterinary Faculty, livestock sectors, wildlife and zoo and pet animal stake holders, if the normalcy is established, by the year end.

I, with my energetic committee members will perform as a team and project the work scopes in order to achieve the set goals by the end of our prospective tenure.

My dear colleagues,

As you all are fully aware the year 2020 was one of the worst periods in the word history owing to the Covid-19 Pandemic. The activities planned by the 72nd Executive committee undoubtedly had a negative impact as a result of this unexpected development and the challenges paused by the lockdown had been tremendous. Yet after a brief dormant period, the 72nd Ex-Co became resilient and motivated with determination and did everything possible for the betterment of the profession adhering to restrictions imposed by the health authorities.

However, I must mention that during the first six months after the 72nd Ex-Co took over responsibilities of the SLVA on 3rd September 2019, that was well before the unprecedented declaration of COVID-19 pandemic, we planned and executed a motivational program for veterinary internees and a number of continuing professional development programs for veterinary professionals including both large and small animal practitioners with the help of reputed international and national resource personnel. In January 2020 we conducted a workshop on Bone plating with the participation of companion animal practitioners, wildlife and zoo veterinarians. To name another few, we contributed to formulate proposals to empower human resources and improve infrastructure facilities for animal diseases investigation and surveillance in the country, to mitigate Human Elephant Conflict/Coexistence, to achieve self-sufficiency in milk and a strategic and action plans to eliminate rabies from Sri Lanka using One Health approach.

During the COVID-19 "panic stage", SLVA was in the forefront to issue print and electronic media briefings assuring the general public that this virus is not transmitted by domestic animals and thus, not to abandon the household pets, livestock and poultry but to adhere to the guidelines issued by the OIE, WHO, WVA and the local health authorities in dealing with them. We took appropriate

actions to create awareness among veterinary professionals and general public regarding safe handling of animals and animal products during the pandemic through Webinars, SLVA website and social media platforms. We contributed with our inputs to DAPH when needed to ensure uninterrupted supply of animal feed, raw materials and animal products. The Ex-Co conducted an online creative drawing competition during the period of lockdown for three categories of school children of families of veterinarians and presented awards and certificates to the best three creations of each of the three categories of children.

We were able to conduct the Annual Scientific Sessions successfully as an International Webinar for the first time in the history of SLVA with the enthusiastic participation of key note speakers, theme speakers and presenters of oral and poster communications from universities, research institutes and Industries from overseas and Sri Lanka. We conducted it at the Faculty of Veterinary Medicine and Animal Science, University of Peradeniya on 3rd and 5th July 2020, where the authors presented their oral scientific communications onsite in the presence of a limited number of audience and larger number joining online which could be considered as a novel experience to the SLVA members, industry personnel and contributors.

We made a collaborative effort with the Sri Lanka Medical Association in conducting a Webinar through One Health approach in preventing the next pandemic on 20th July 2020 with the participation of world renowned subject matter specialists from overseas and Sri Lanka as resource personnel. Some Ex-co members with the cooperation of few of its members conducted another Webinar on 21st July for Wildlife and Zoo veterinarians to discuss the issues faced by them especially in the field. The moderators realised that the lack of protocols for various procedures needed more attention and SLVA was to intervene in formulating protocols.

The working group appointed by the SLVA Ex-Co finalized the strategic plan for Elimination of Rabies from Sri Lanka, and the concept of FORESAW-SL (Forum for Research Animal Welfare Sri Lanka) was further discussed, a constitution drafted by a committee appointed by the Ex-Co for the purpose and a logo for the same was finalised for a soft launch at the induction ceremony of 73rd President. In fact we had to postpone the Annual General Meeting and the Ceremonial Induction of the new President which were scheduled to be held in October 2020 as a physical gathering in just one week before the scheduled date due to the emergence of significant number of new Covid-19 cases in Kandy district and some other areas in the country.

Amidst all these obstacles finally we managed to conduct the AGM and the Induction Ceremony of the 73rd President glamorously as a hybrid event for the first time in the history of SLVA at the Grand Kandyan Hotel, Kandy on 18th December 2020.

73RD EXECUTIVE COMMITTEE 2020/2021

The main objective of the AGM was to elect the next executive committee since the tenure of 72nd Executive committee was ended. Accordingly the outgoing president Dr. Niranjala de Silva invited members to appoint an interim president to conduct the election and appoint the new president and secretary for the 73rd Exco. Prof. Basil Alexander was appointed as the interim president and he






SRI LANKA VETERINARY JOURNAL (SLVJ) – VOLUME 66 (2)
